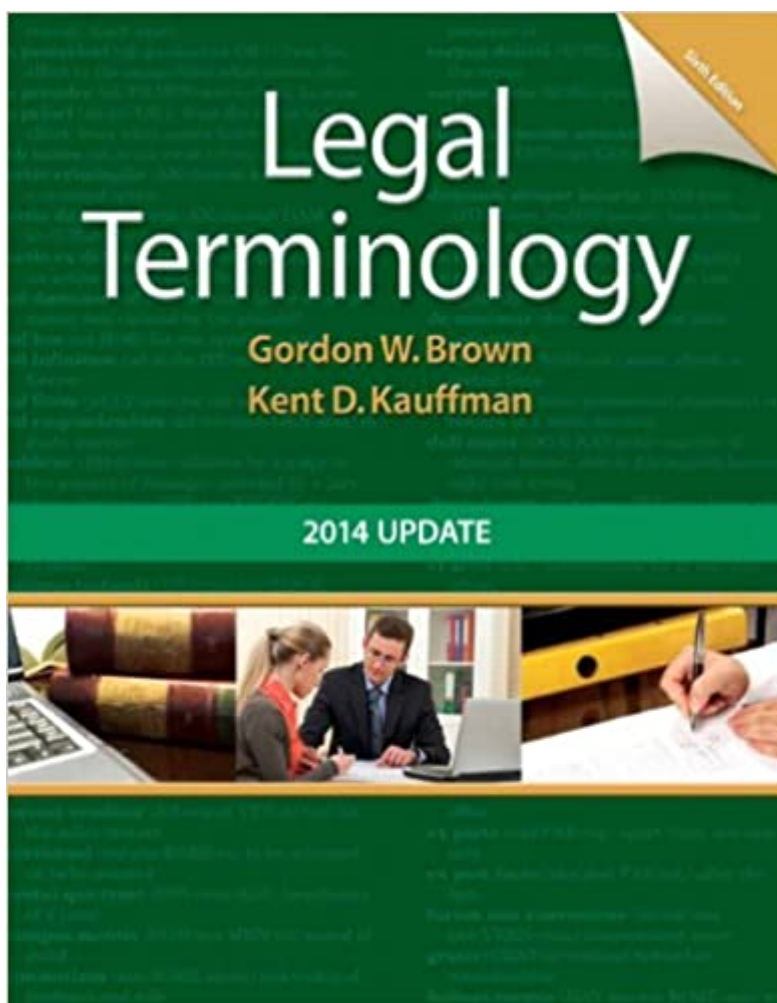

The editor of this book and the corresponding online materials did a terrible job. Every chapter has errors. It's maddening to expect a student to pay an exorbitant fee for materials that contain glaring oversights and mistakes. For example, the online flashcards contain a term on one side, and the definition on the other side. But the definition side ALSO contains the phonetic pronunciation of the word, so you're looking at the pronunciation of the term on the side that it only supposed to contain the definition. Other examples involve the online quizzes and tests that have contradictory answers. There's no shortage of room for improvements.
