

This is an impressive technical analysis of the legal aspects of marriage for the LGBT community. But what impresses me most about this book is how thoughtfully and, well, lovingly Scott walks the reader through the complex maze of legal rules that apply to what is at its heart a deeply personal and emotional decision.

As a mortgage broker and advisor to my clients, I have often been confronted with the challenges that my gay and lesbian clients face: separate federal taxes, capital gains issues when selling property to each other, issues lending to one who is a citizen and spouse who is not, income qualification for a house when a spouse passes (but their SS benefits did not), etc. This book is a great resource for understanding the challenges and changes that recent progress in the laws have created; all good! I highly recommend this book for anyone who has gay or lesbian clients or simply wants to understand the challenges that these clients and friends face.

I really liked Whether to Wed. It is a remarkably clear guide to the convoluted, rapidly-changing area of gay and lesbian marriage. I work with wealthy families who already have enough complexity to deal with in their marital agreements, relationships, tax and estate planning, family businesses, and real estate dealings.
