These legal briefs make law school so much more understandable. The rules that are distilled out of every case aren't always the rule that the professor keys in on, but more often than not, it is. And it is quite helpful when preparing for class to have the essence of the case laid out for you. I would recommend these for every class, but particularly for Business Organizations. I will usually get a previous edition of the textbook (to save tons of money), then get the Casenote Legal Briefs for the current edition so that I can get the jist of the few cases that are not included in the previous edition of the textbook. These are certainly helpful, and I definitely recommend them for every student.

Every law student knows the fear of getting cold called but with this book you can easily reference the case you were supposed to read. This book gives you the ability to answer your teacher's questions while pretending that you might actually be learning something in law school besides what cripplingly debt is.
