

Not so, says Malcolm Feeley in this provocative and original book. The qualitative analysis of the lower court system, offered in "The Proccess" is a worthwhile and very relevant read for anyone seeking to understand the inner workings of criminal courts. The author does an excellent job providing an explanation for how courts work and why they produce so few trials.
