

Then in 2000, Rapid Return Medical Billing served Blue Cross Blue Shield of Minnesota in testing their Optical Character Reader (OCR), which autnomatically converted paper claims to National Standard Format (NSF) files.Ã Â In 2001, Bonnie began serving on the Medicare Advisory committee for the State of Minnesota (PCOM).Ã Â In 2001, Rapid Return Medical Billing won the Medisoft contest for setting up the first 100 clinics to transmit electronically.Ã Â In 2002, Bonnie joined the HBMA (Healthcare Billing and Management Association).Ã Â In 2006, Bonnie began focusing solely on Medisoft by starting a separate company called Softouch Software and billing company known as Billing Buddies.Ã Â Bonnie is also the creator and host of the Google group called Medisoft and Medical Billing.
