

I have since returned the kindle edition and ordered the paperback. Unless you have incredible eyesight with the ability to read super tiny writing, the kindle version is not for you. Now you can enlarge sections temporarily with your fingers like you do on a website on your tablet or smartphone. but personally that would not be very conducive to me successfully completing my course with the book.
